### GENERAL ORDINANCE NO. 3, 2013

*General Ordinance #3, 2013 is an Ordinance Adding Section 96.10 to Chapter 96 of the Code of Ordinances of the City of Beech Grove, Indiana*

**WHEREAS,** citizens set out waste on public city property for collection from the sanitation department; and

**WHEREAS,** often people go through waste when placed on public property causing waste to scatter over roads and alleys; and

**WHEREAS,** thieves use the cover of picking trash to avoid suspicion; and

**WHEREAS,** permits set in place would help identify pickers; and

**WHEREAS,** the Common Council has determined waste collection should only be handled by the property owner the waste comes from, the Sanitation Department, and permit holders.

**NOW THEREFORE, BE IT ORDAINED** by the Common Council of the City of Beech Grove, Indiana that Chapter 96 Garbage and Refuse Collection, is hereby amended by the addition thereto of new Section 96.10 and read as follows:

- It shall be unlawful for a person to take waste from a dumpster container or bag when the container has been placed on public city owned property without a permit other than the property owner and the Beech Grove Department of Sanitation.
- Waste may only be picked up from Dawn until Dusk.
- Permits obtained through City Hall must include a Government Issued Identification number and are good for a period of 1 year and cost of \$5.
- A violation of this section shall be subject to a fine of not less than \$50.

**NOW THEREFORE, BE IT ORDAINED** that this Ordinance only applies to the removal of trash listed above.

**NOW THEREFORE, BE IT ORDAINED** that this Ordinance goes into effect 30 days after approval of the Common Council, signed by the Council President, attested by the Clerk Treasurer and signed by the Mayor.
