Notice is hereby given to the taxpayers of the City of Beech Grove, Indiana ("City") that the Common Council of the City will meet in the Council Chambers, City Hall, 806 Main Street, Beech Grove, Indiana, at the hour of 7:00 p.m. (Local Time) on July 2, 2012, to conduct a public hearing and consider the following additional appropriation of the bonds which the Common Council has determined to issue. The Common Council considers necessary an appropriation in the amount not to exceed \$1,995,000 on account of the cost of financing the acquisition of a fire truck and an ambulance, improving several municipal building roofs and various infrastructure improvement and updates in the City and the incidental expenses in connection therewith. The funds to meet such additional appropriation are to be provided by the issuance and sale of bonds by the City.

The foregoing appropriation is in addition to all appropriations provided for in the existing budget and tax levy.
