

BEECH GROVE BOARD OF ZONING APPEALS
MEETING MINUTES

New Petitions

2022-DVB-003- 5457 Elmwood Avenue- Singh, Baljinder & Satnam Sangha, by David Kingen and Emily Duncan. Request for a variance of development standards of the Consolidated Zoning and Subdivision Ordinance to provide for 30-foot front transitional yard (minimum 150 feet required) and a ten-foot east side yard (30 feet required).

Petitioner requests a continuance until next meeting. Rick Greenfield made a motion to continue the petition, Jeff Yeager seconded the motion, which was approved by unanimous voice vote of four to zero.

2022-DVB-002- 4221 South Emerson Avenue- Glenn Harvey, by Victor Mickel. Request for a variance of development standards of the Consolidated Zoning and Subdivision Ordinance to provide for a gas station/convenience store with a ten-foot front transitional yard (fifteen feet required) with four interior landscape shade trees (six required).

Petitioner- Petitioner presented the project with drawings to the board. The current building will be demolished, and a new larger building will take its place. This project will reduce the current curb cuts from four down to two.
