

General Ordinance No. 10, 2020

General Ordinance No. 10, 2020, is an ordinance that amends Chapter 77 of the Code of Ordinances for the City of Beech Grove pursuant to Through Streets and Stop Streets.

WHEREAS, Grovewood Drive has become exceedingly busy and several residents have approached the city asking for assistance in slowing down traffic that travels on the roadway; and

WHEREAS, Alton in the area of Second Avenue, has become busier and more children have moved into the area; and

WHEREAS, local residents have approached the city as well asking for assistance in slowing down traffic traveling on Alton; and

WHEREAS, speed humps or speed bumps are not recommended by our DPW or Police Departments.

NOW THEREFORE BE IT AFFIRMED that the Common Council desires to amend Chapter 77 of the Code of Ordinances for the City of Beech Grove concerning "Through Streets and Stop Streets".

NOW THEREFORE BE IT FURTHER AFFIRMED that the Common Council desires the following language be placed in Chapter 77 of the Code of Ordinances for the City of Beech Grove:

NOW THEREFORE BE IT AFFIRMED that the Common Council desires to amend Chapter 77 of the Code of Ordinances for the City of Beech Grove.

NOW THEREFORE BE IT FURTHER AFFIRMED that this ordinance only applies to Chapter 77 of the Code of Ordinances for the City of Beech Grove and no other ordinance.

NOW THEREFORE BE IT FURTHER AFFIRMED that this ordinance shall go into effect 30 days after passage by the Common Council, signed by the Council President Pro-Tem, attested by the Clerk Treasurer and signed by the Mayor.
