Ordinance / Resolution Number: 9

Be it ordained/resolved by the **Beech Grove City Council** that for the expenses of **BEECH GROVE CIVIL CITY** for the year ending December 31, **2021** the sums herein specified are hereby appropriated and ordered set apart out of the several funds herein named and for the purposes herein specified, subject to the laws governing the same.
