

GENERAL ORDINANCE # 10, 2021

General Ordinance 10, 2021, is an ordinance that amends Chapter 73 (Pedestrians) in the City of Beech Grove Code of Ordinances that establishes rules concerning the "Franciscan Trail".

WHEREAS, the City of Beech Grove has constructed a 2.2-mile walking trail which winds through our park system and local neighborhoods; and

WHEREAS, the "Franciscan Trail" is set to open by the end of calendar year 2021, although many people are already taking advantage of the trail; and

WHEREAS, the Park Boards was asked to research and develop a set of rules for all to abide by who utilize the "Franciscan Trail"; and

WHEREAS, the City of Beech Grove will benefit from this investment in hopes of attracting more people to our city.

NOW THEREFORE BE IT AFFIRMED that the Common Council desires to develop rules for the "Franciscan Trail."

NOW THEREFORE BE IT FURTHER AFFIRMED that the Common Council desires to add the following into the Code of Ordinances for the City of Beech Grove.

PLEASE ADD THE FOLLOWING:

Section 73.15: Rules for the Franciscan Trail

(A) GENERAL RULES:

Stop at street intersections for cross traffic. (cars have the right of way)

Keep to the right.

Communicate with others before passing.

Yield to pedestrians.

Do not trespass on private property along the trail or disturb plants.

Obey signage.

Keep dogs on a short leash and clean up after them.

Do not litter.

No alcohol or tobacco use.

No motorized vehicles.

Follow all other Beech Grove Park System rules as posted.

HOURS

OPEN - Dawn to dusk yearround.

NOW THEREFORE BE IT AFFIRMED that the Common Council desires to add this Ordinance into the Code of Ordinances for the City of Beech Grove.

NOW THEREFORE BE IT FURTHER AFFIRMED that this Ordinance only applies to rules for the "Franciscan Trail" and no other Ordinance.

NOW THEREFORE BE IT FURTHER AFFIRMED that this Ordinance shall go into effect 30 calendar days after passage by the Common Council, signed by the Council President Pro-Tem, attested by the Clerk Treasurer, and signed by the Mayor.
