

**GENERAL ORDINANCE NO. 26, 2016**

*General Ordinance No. 26* is an ordinance that amends Chapter 77 of the Code of Ordinances for the City of Beech Grove pursuant to one-way streets and alleys.

**WHEREAS**, a new road has been constructed causing traffic patterns to change; and

**WHEREAS**, corrections in the current Code of Ordinance book needs to be made to correspond with the current traffic flow patterns.

**WHEREAS**, Chapter 77 of the Code of Ordinances must be updated and certain streets will need to be deleted as they no longer exist: and

**WHEREAS**, the fines in Chapter 77 of the Code of Ordinances are ambiguous and need updating to reflect actual fine amounts.

**NOW THEREFORE BE IT ORDAINED** that the Common Council desires to amend Chapter 77 of the Code of Ordinances for the City of Beech Grove.

**NOW THEREFORE BE IT FURTHER ORDAINED** that the Common Council desires the following changes be made in Chapter 77 of the Code of Ordinances for the City of Beech Grove.

**DELETE THE FOLLOWING IN ITS ENTIRETY:**

First Alley north of Main St.	East line of Sixth Ave. and the west line of Seventh Ave.	East to West	9-1975
First Ave.	South line of Main St. to the west Line of new Emerson Ave. (Intersection of First and Emerson Ave.)	East to West	9-1975
Second Ave.	South line of Bethel Ave. and north Line of Churchman Ave.	North to South	9-1975
Bellefontaine St.	The west end of First Ave. to the East line of Second Ave.	East to West	9-1975
Sixteenth Ave.	South line of Albany St. and the North line of Main St.	North to South	9-1975

(B) Whoever violates any provision of this schedule shall be fined no less than \$1 nor more than \$400 for such violation.

## **SCHEDULE II. THROUGH STREETS AND STOP STREETS.**

### **INTERSECTION**

### **CONTROLS-DESCRIPTION**

Bellfontaine and Schaff

Stop sign e/b, w/b, n/b, and s/b

(B) Penalty. Whoever violates any provision of this schedule shall be fined not less than \$1 nor more than \$100 for such violation.

## **SCHEDULE IV. SPEED LIMITS.**

(C) Penalty.

(1) Persons who operate their motor vehicles upon the designated streets, alleys, or parkways in excess of the posted speed limits established herein shall be fined in an amount of not to exceed \$500 by a court of competent jurisdiction.

(2) Any person who violates the provisions of Ord. 31-1984 may be fined in an amount no less than \$1 or more than \$1,000. (Ord. 31-1984, passed 12-17-84)

(3) Any person who violates the provisions of Ord. 7-1994 may be fined in an amount not less than \$1 or more than \$500. (Ord. 7-1994, passed 7-5-94)

## **ADD THE FOLLOWING:**

### **SCHEDULE I. One-Way Streets and Alleys**

(A) traffic shall move only in the direction indicated upon the following streets:

<b><u>STREET</u></b>	<b><u>BETWEEN</u></b>	<b><u>SIDE</u></b>	<b><u>ORD.</u></b>
Butler Ave.	South from the Beech Grove High School Parking lot to Adelaide St.	North to South	26-2016
Fourteenth Ave.	South from Southern Ave. to Albany St.	North to South	26-2016
Fifteenth Ave.	North from Albany St. to Southern Ave.	South to North	26-2016
Sixteenth Ave.	South from Detroit St. to Main St.	North to South	26-2016
Parkway Dr.	Thirteenth St. East to Eleventh Ave.	West to East	26-2016

(B) Penalty. Whoever violates any provision of this schedule shall be fined \$75 plus state statutory required court fees.

**SCHEDULE II. THROUGH STREETS AND STOP STREETS.**

**INTERSECTION**

**CONTROLS-DESCRIPTION**

Bellfontaine and Schaff

Stop sign e/b, n/b, s/b

(C) Penalty. Whoever violates any provision of this schedule shall be fined \$75 plus state statutory required court fees.

**SCHEDULE IV. SPEED LIMITS.**

(C) Penalty. Persons who operate their motor vehicles upon the designated streets, alleys, or parkways in excess of the posted speed limits established herein shall be fined in an amount of \$75 plus state statutory required court fees.

**NOW THEREFORE BE IT ORDAINED** that the Common Council desires to amend Chapter 77 of the Code of Ordinances pursuant to traffic pattern on designated streets.

**NOW THEREFORE BE IT FURTHER ORDAINED** that this ordinance only applies to the above listed streets.

**NOW THEREFORE BE IT FURTHER ORDAINED** that this ordinance shall go into effect thirty days after passage by the Common Council, signed by the Council President Pro-Tem, attested by the Clerk Treasurer and signed by the Mayor.
