

Additional Appropriation Ordinance # 2, 2023

WHEREAS, it has been determined that it is now necessary to appropriate more money than was originally appropriated in the annual budget; and

WHEREAS, the City of Beech Grove, IN, ("City") is a duly formed municipal corporation within the State of Indiana, governed by its duly elected Mayor and Council ("Council") and;

WHEREAS, the Council has the duty and authority to maintain and allocate funds as necessary from the duly adopted budget to maintain the fiscal integrity of the City and maximize efficiency; and

WHEREAS, it becomes necessary to appropriate more funds for the fiscal integrity of the City.

NOW THEREFORE BE IT AFFIRMED that the Beech Grove Common Council desires to appropriate the funds listed below, based on the recommendation of the Clerk Treasurer:

Sec. 1. Whereas a public hearing was held on June 5, 2023 after having been properly advertised.

Sec. 2. Now therefore, be it ordained by the City of Beech Grove Common Council of the City of Beech Grove, Marion County, that the expenses of the taxing unit the following additional sums of money are hereby appropriated out of the funds named and for the purposes specified, subject to the laws governing the same:
