

General Ordinance # 5, 2021

General Ordinance No. 5, 2021, is an Ordinance that adds a new Federal Holiday to the City of Beech Grove's Personnel Manual.

WHEREAS, Congress recently passed legislation proclaiming Juneteenth as a National Holiday; and

WHEREAS, President Biden recently signed this legislation into law; and

WHEREAS, June 19th of each year is now proclaimed Juneteenth holiday, and employees shall be afforded the same benefits for this holiday as they receive for other established holidays.

NOW THEREFORE BE IT AFFIRMED that the Common Council desires to amend the City of Beech Grove Personnel Manual to include Juneteenth as a recognized holiday in the City of Beech Grove.

NOW THEREFORE BE IT FURTHER AFFIRMED that the Common Council instructs that the following Federal Holiday be inserted into the City of Beech Grove Personnel Manual.

JUNETEENTH HOLIDAY

NOW THEREFORE BE IT AFFIRMED that this Ordinance only applies to the above listed Federal Holiday.

NOW THEREFORE BE IT FURTHER AFFIRMED that the Common Council desires that employees are compensated in the same manner for this Federal Holiday as they are for all others.

NOW THEREFORE BE IT FURTHER AFFIRMED that this Ordinance shall go into effect thirty days after passage by the Common Council, signed by the Council President Pro-Tem, attested by the Clerk Treasurer, and signed by the Mayor.
