

ADDITIONAL APPROPRIATION ORDINANCE #7, 2022

WHEREAS, it has been determined that it is now necessary to appropriate more money than was originally appropriated in the annual budget; and

WHEREAS, the City of Beech Grove, IN, ("City") is a duly formed municipal corporation within the State of Indiana, governed by its duly electing Mayor and Council ("Council") and;

WHEREAS, the Council has the duty and authority to maintain and allocate funds as necessary from the duly adopted budget to maintain the fiscal integrity of the City and maximize efficiency; and

WHEREAS, it has become necessary to appropriate more funds for the fiscal integrity of the City.

NOW THEREFORE BE IT AFFIRMED that the Beech Grove Common Council desires to appropriate the Funds listed below, based on the recommendation of the Clerk Treasurer.


