

GENERAL ORDINANCE # 9, 2021

General Ordinance # 9, 2021, is an ordinance that amends Chapter 77 of the Code of Ordinances for the City of Beech Grove that controls Traffic Schedules.

WHEREAS, recently, the City of Beech Grove repaved sections of South 4th which has caused traffic speed to increase on South 4th; and

WHEREAS, recently, citizens living near this intersection have begun placing their own portable signs in their yards asking drivers to slow down when passing through the area of 4th and Birch; and

WHEREAS, the Council Representative for District 4, has submitted a request for a stop sign at the intersection of 4th and Birch to control the traffic flow in all three directions; and

WHEREAS, it is noted that currently there seems to be a large contingent of children living in the area in close proximity to the intersection.

NOW THEREFORE BE IT AFFIRMED that a 3-way stop is recommended to be installed to slow down the traffic around 4th and Birch.

NOW THEREFORE BE IT FURTHER AFFIRMED that the Common Council desires to amend Chapter 77 of the Code of Ordinances concerning Traffic Schedules and asks that the following be inserted into the Code of Ordinances for the City of Beech Grove.

Chapter 77 Traffic Schedules

Schedule II. Through Streets and Stop Signs

ADD THE FOLLOWING: STOP SIGN

INTERSECTION

4th and Birch

CONTROLS-DESCRIPTION

e/b Birch

s/b 4th

n/b 4th

NOW THEREFORE BE IT AFFIRMED that the Common Council desires to Amend Chapter 77 of the Code of Ordinances concerning Traffic Schedules.

NOW THEREFORE BE IT FURTHER AFFIRMED that this Ordinance only applies to the intersection of 4th and Birch and no other intersection.

NOW THEREFORE BE IT FURTHER AFFIRMED that this Ordinance shall go into effect 30 days after passage by the Common Council, signed by the Council President Pro-Tem, attested by the Clerk Treasurer and signed by the Mayor.
