

## GENERAL ORDINANCE NO. 14, 2012

**General Ordinance No. 14, 2012** is an ordinance that amends Chapter 72, Section 72.47 Subsection (A): (2), (8), and Subsection (B) and Chapter 72, Section 72.49 of the "Code of Ordinances" of the City of Beech Grove, Indiana

**WHEREAS,** accommodations must be made for persons with a handicap to park within a short distance from their residence.

**WHEREAS,** the City of Beech Grove must continue to inspect sidewalks, curbs, and infrastructure to ensure proper access for persons with a handicap; and

**WHEREAS,** a person with a documented disability has come forward requesting a change in the current ordinance to accommodate parking.

**NOW THEREFORE BE IT ORDAINED** by the Common Council of the City of Beech Grove, Indiana that Chapter 72, Sections 72.47 Subsection (A): (2), (8), and Subsection (B) and Chapter 72, Section 72.49 of the "Code of Ordinances" of the City of Beech Grove be ammended.

**NOW THEREFORE BE IT ORDAINED** by the Common Council of the City of Beech Grove, Indiana finds cause to amend Chapter 72 of the "Code of Ordinances" for the City of Beech Grove Indiana to read as follows:

Chapter 72, Section 72.47 Subsection (A); (2) to read as follows:

Permits are restricted to a **household**.

Chapter 72, Subsection (A); (8) to read as follows:

The City shall paint curbing designating such parking space with suitable **blue paint markings up to (40) feet in length per property lot.**

Chapter 72, Subsection (B):

Delete the words "**parking meter**" on line 4

(67 Code 75.33)

Chapter 72.49 ENFORCEMENT

No vehicle other than those authorized by a valid **handicap plate or card of the person(s) living in the registered residence** of which a parking space is designated shall park in the provided parking space marked herein. **The permit holder reserves the right to contact law enforcement for the purpose of enforcement should any vehicle not authorized be parked in a properly marked and designated handicap spot.**

**BE IT FURTHER ORDAINED** that the Common Council finds it just to amend Chapter 72, Section (A), Subsection (A): (2), and (8) and Subsection (B) and Chapter 72, Section (B) of the "Code of Ordinances of the City of Beech Grove, Indiana.

**BE IT FURTHER ORDAINED** that all ordinances or parts of ordinances in conflict herewith are hereby repealed.

**BE IT FURTHER ORDAINED** that this ordinance shall be in effect sixty (60) days after being approved by the Common Council, attested by the Clerk Treasurer and signed by the Mayor.


