

## GENERAL ORDINANCE #1, 2014

**Ordinance #1, 2014** is an Ordinance that establishes the Beech Grove Public Safety Program.

**WHEREAS;** the Common Council of the City of Beech Grove has codified certain ordinances comprising the Beech Grove City Code of Ordinances; and

**WHEREAS;** the City of Beech Grove, through it's Police Department, is charged with providing for the public's safety; and

**WHEREAS;** the City of Beech Grove collects revenue through it's safe driver deferral program; and

**WHEREAS;** the Beech Grove Police Department does not currently have a traffic and/or public safety division or program.

**NOW THEREFORE BE IT ORDAINED** that the Common Council desires to establish the Beech Grove Public Safety Program.

**NOW THEREFORE BE IT FURTHER ORDAINED** that the Common Council desires to amend Chapter 33 of the "Code of Ordinances: as prescribed as follows:

### **ADD Chapter 33 - "Beech Grove Public Safety Program"**

The Common Council hereby establishes the Beech Grove Public Safety Program as set forth herein.

### **ADD Section 33.40 "Establishment of Program"**

(A) In an effort to increase public safety, the City of Beech Grove Police Department is authorized and delegated to develop and implement a public safety program ("Program").

(B) The Program shall provide additional overtime opportunities for officers of the City Police Department.

(C) Officers participating in the Program shall conduct patrols focused exclusively on the enforcement of the Beech Grove Code of Ordinances and in accordances with the Program's metrics.

(D) All citations and/or tickets that result from the Program shall be filed in the Beech Grove City Court.

(E) The Program shall not replace or be in contravention of existing state laws or programs but shall be complementary to and in aid of such laws or programs.

**ADD Section 33.41 “Administering the Program”**

(A) The Program shall be administered by the “Administrator”.

(B) The Administrator shall be the Chief of Police or his designee.

(C) The Administrator shall establish the metrics of the Program.

(D) On a monthly basis, the Administrator will determine the number of hours the Program will be available.

(E) Participating officers will be compensated at their respective overtime rate.

**ADD Chapter 33, Sub-section 42 “Funding of Program”**

(A) Twenty-five percent (25%) of all monies collected through the Beech Grove Safe Driver Deferral Program, from the preceding year, shall be appropriated to fund the Program.

(B) The Beech Grove Police Department’s annual budget shall include an additional overtime line-item, that corresponds with the appropriation for the Program.

(C) The Program may not provide overtime opportunities in excess of the Program’s funding.

(D) The Common Council may make additional appropriations, as it sees fit to fund the Program.


**NOW THEREFORE BE IT ORDAINED** that the Common Council has found it just to establish the Beech Grove Public Safety Program.


**NOW THEREFORE BE IT FURTHER ORDAINED** that the Common Council desires to amend Chapter 33 of the Code of Ordinances for the City of Beech Grove.


**NOW THEREFORE BE IT FURTHER ORDAINED** that this Ordinance shall go into effect thirty (30) days after passage of the Common Council, attested by the Clerk Treasurer and signed by the Mayor.


Adopted and Approved in an open meeting of the Common Council of the City of Beech Grove, Indiana on the 7 day of APRIL 2014.






