

GENERAL ORDINANCE NO. 26, 2012

General Ordinance No. 26, 2012 is an ordinance that amends Chapter 34, Section 34.15 (B) of the “Code of Ordinances” of the City of Beech Grove, Indiana pursuant to ambulance responses outside the corporate city limits of the City of Beech Grove.

WHEREAS, section 34.15 (B) of the Beech Grove “Code of Ordinances” defines rate fees for Emergency Ambulance Service provide by the City of Beech Grove and its Fire Department and;

WHEREAS, more and more our ambulance is being dispatched out of our city to provide basic and advanced life support services causing a stress on our employees, equipment and vehicles and;

WHEREAS, more revenues must be generated from non taxable programs to help offset the costs associated with provided basic and lifesaving services such as ambulance service and;

WHEREAS, currently provisions of this ordinance do not call for a difference in fees depending on where the response may be located.

NOW THEREFORE BE IT FURTHER ORDAINED that the Common Council of the City of Beech Grove Indiana desires to amend Chapter 34, Section 34.15 of the Code of ordinances of the City of Beech Grove, Indiana.

BE IT FURTHER ORDAINED that the Common Council of the City of Beech Grove amends Chapter 34, Section 34.15(B) to read as follows:

(B) The following rate schedule is established for emergency ambulance service provided by the Beech Grove Fire Department.

Service	Rate
Basic Life Support	\$ 700.00
Advances Life Support	\$ 900.00
Advanced Life Support – 2	\$1,100.00
Signature of Release	\$ 65.00
Extrication from a Vehicle or Equipment	\$ 750.00
Water Rescue	\$ 400.00
Loaded Mileage	\$ 16.00
Hazardous Material Response	\$ 400.00 for first hour, 25.00 Every 15 minutes after the first hour

DELETE: Out of City response \$ 125.00

ADD THE FOLLOWING:

Response outside of the City of Beech Grove Corporate City Limits

Base Life Support	\$ 1,353.00
Advanced Life Support	\$ 1,628.00
Advanced Life Support – 2	\$ 1,947.00
Loaded Mileage	\$ 28.00

BE IT FURTHER ORDAINED that the Common Council finds it just to amend Chapter 34, Section 34.15 (B) of the “Code of Ordinances” of the City of Beech Grove Indiana.

BE IT FURTHER ORDAINED that all ordinances or parts of ordinances in conflict herewith are hereby repealed.

BE IT FURTHER ORDAINED that this ordinance shall go into effect sixty (60) days after passage by the Common Council, attested by the Clerk Treasurer, and signed by the Mayor.
