

GENERAL ORDINANCE NO 3, 2020

General Ordinance No. 3, 2020, is an ordinance that amends Chapter 34, Section 34.15 (B) of the Code of Ordinances for the City of Beech Grove pursuant to charges for ambulance responses generated by the Beech Grove Fire Department.

WHEREAS, the City must find other ways to generate funds to operate government, other than depending on property taxes; and

WHEREAS, the Beech Grove Fire Department has provided emergency ambulance services since 1973 and began billing for services provided in 1987; and

WHEREAS, from time to time, rates are recommended to be adjusted to capture increases approved by government and private agencies for payment of claims; and

WHEREAS, in 2019, the City of Beech Grove Fire Department responded to over 4,695 calls for emergency services.

NOW THEREFORE BE IT AFFIRMED that the Common Council of the City of Beech Grove desires to amend Chapter 34.15 of the Code of Ordinances for the City of Beech Grove, Indiana.

NOW THEREFORE BE IT FURTHER AFFIRMED that the Common Council of the City of Beech Grove instructs that the following changes be made in Chapter 34, Section 34.15 (B):

DELETE Chapter 34, Section 34.15 (B) in its entirety and replace with the following:

Chapter 34, Section 34.15 (B):

Basic Life Support	\$2,004.00
Advanced Life Support - Level 1	\$2,412.35
Advanced Life Support - Level 2	\$2,885.03
Signature of Release	\$75.00
Milage	\$41.49 (per loaded mile)
Community Para Medicine	\$250.00
Hazardous Material REsponse	\$500.00 first hour \$50.00 for every 15 minutes after the first hour
Turn-Out Gear Replacement	\$2,500.00 (per set)
Turn-Out Gear Decontamination / Cleaning	\$500.00 (per set if sent out for cleaning) \$100.00 (per set if cleaned in house)

THEREFORE BE IT AFFIRMED that the Common Council desires to amend Chapter 33 of the Code of Ordinances for the City of Beech Grove.

THEREFORE BE IT FURTHER AFFIRMED that this Ordinance only applies to Chapter 34 of the Code of Ordinances for the City of Beech Grove and no other chapter.

THEREFORE BE IT FURTHER AFFIRMED that this Ordinance shall go into effect on June 1, 2020 after passage by the Common Council, attested by the Clerk Treasurer, and signed by the Mayor.




