

RESOLUTION # 13, 2013

Resolution #13, 2013 is a Resolution that adopts the Marion County Multi-Hazard Mitigation Plan.

WHEREAS, the Multi-Hazard Mitigation Plan has been prepared by Christopher B. Burke Engineering, LTD, for Marion County, the City of Beech Grove, the City of Lawrence, the City of Southport, and the Town of Speedway, Indiana; and

WHEREAS, the Multi-Hazard Mitigation Plan recommends many activities which will protect the people and property of Marion County, the City of Beech Grove, the City of Lawrence, the City of Southport, and the Town of Speedway, Indiana, affected by natural hazards; and

WHEREAS, the City of Beech Grove, per the 2007 CRS Coordinator's Manual criteria, the governing body must adopt the MHMP by resolution in order to be eligible for FEMA funding and keep their CRS status.

NOW THEREFORE BE IT ORDAINED that the Common Council of the City of Beech Grove desires to be part of the Marion County Multi-Hazard Mitigation Plan.

NOW THEREFORE BE IT FURTHER ORDAINED by the Common Council of the City of Beech Grove that the following occurs.

1. The Multi-Hazard Mitigation Plan for Marion County, Indiana, the City of Beech Grove, is adopted as the official plan of the City of Beech Grove, Indiana.

NOW THEREFORE BE IT ORDAINED by the Common Council of the City of Beech Grove, Indiana that this plan is adopted as the official plan of the City of Beech Grove, Indiana.

NOW THEREFORE BE IT FURTHER ORDAINED by the Common Council of the City of Beech Grove that this Resolution only applies to the Hazard Mitigation Plan.

NOW THEREFORE BE IT FURTHER ORDAINED that this Resolution shall go into effect immediately after passage by the Common Council, signed by the Council President, attested by the Clerk Treasurer and signed by the Mayor.
