

RESOLUTION 14, 2012

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BEECH GROVE, INDIANA
ADOPTING THE AMERICANS WITH DISABILITIES ACT (ADA)
ADA COORDINATOR AND PROCEDURES**

WHEREAS, the Federal government enacted the American with Disabilities Act of 1990 (ADA) to prevent discrimination of the physically and mentally disabled relating to employment and access to public facilities; and

WHEREAS, in compliance with Title II of the ADA the City of Beech Grove shall name an ADA Coordinator; and

WHEREAS, in compliance with Title II of the ADA the City of Beech Grove shall adopt a grievance procedure for resolving complaints alleging violation of Title II of the ADA; and

WHEREAS, in compliance with Title II of the ADA the City of Beech Grove shall post the ADA coordinator's name, office address, and telephone number along the ADA Notice and ADA grievance procedure on its website.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Beech Grove, Indiana: Joe Prindle is designated as the ADA Coordinator for the City.

The Notice under the Americans with Disability Act, a copy of which is attached hereto, is adopted as the City of Beech Grove Notice under the Americans with Disabilities Act.

The City of Beech Grove Grievance Procedure under the American with Disabilities Act, a copy of which is attached hereto, is adopted as the grievance procedure for addressing complaints alleging discrimination of the basis of disability in the provision of services, activities, programs or benefit by the City of Beech Grove.

In compliance with Federal and State laws as set forth above, the City Council resolves to post the required information regarding the ADA coordinator, Notice under the Americans with Disabilities Act, and City of Beech Grove Grievance Procedure under the Americans with Disabilities Act on its website and at such other locations as may be determined from time to time.
