*Salary Ordinance for Appointed Officers and Employees*

An ordinance fixing salaries of appointed officers and employees of the City of Beech Grove, Indiana, for the year 2010.

Be it ordained by the Common Council of the City of Beech Grove, Indiana

Members of the Police Department shall receive the indicated additional salary for the following: (a) Graduate of the Indiana Law Enforcement Academy - \$3,000.00; and (b) Detective - \$1,500.00.

**Section 2.** Each full time employee of the City of Beech Grove shall receive a longevity increment of One Hundred Dollars (\$100.00) per year for each full year (or major portion thereof) of prior service to the City as of January 1, 2010.

**Section 3.** In addition to the foregoing each full time employee of the City of Beech Grove shall receive such education allowances, meal pay, uniform reimbursement and other stipends that are set forth in the Beech Grove City Employee Handbook or are required by applicable statutes.

**Section 4.** The rate shown as wages and salaries for the positions listed are the maximum rates. The salaries established are subject to approval by the Department of Local Government Finance of a levy and tax rate sufficient to fund them.

This ordinance shall become effective on January 1, 2010.
