
ORDINANCE FOR APPROPRIATIONS AND TAX RATES

Be it ordained by the BEECH GROVE CIVIL CITY unit, Marion County, Indiana that for the expenses of BEECH GROVE CIVIL CITY for the year ending December 31, 2012 the sum of \$10,111,459, as shown on Budget Form 4-A are hereby appropriated and ordered set apart out of the several funds herein named and for the purposes herein specified, subject to the laws governing the same. Such sums herein appropriated shall be held to include all expenditures authorized to be made during the year, unless otherwise expressly stipulated and provided for by law. In addition, for the purposes of raising revenue to meet the necessary expense of BEECH GROVE CIVIL CITY, a total property tax levy of \$6288922 and a total tax rate of 1.8634 as shown on Budget Form 4-B are included herein. Budget Form 4-A and 4-B for all funds and departments are incorporated by the signing of this form and must be completed and submitted in the manner prescribed by the Department of Local Government Finance.


